**Getting Started:**

- ◆ Print this sheet, complete & mail it to us. If you do not have a printer, email us and we will send you a copy.

**Requirements:**

- ◆ At least one of the spouses must have habitually lived in the province where you will start your divorce action for at least one full year, prior to starting an action for divorce.
- ◆ You must be living separate and apart at the time the divorce action is started.

**What you should know:**

- ◆ Filing jointly (if possible) is easier, quicker, less adversarial, and less expensive than filing a sole action; and requires the full cooperation of both spouses.
- ◆ Divorce actions on the grounds of separation typically take from 2 to 4 months to conclude, but it is not necessary to wait until one year of separation to begin the process. You may begin the divorce action once you are separated and a divorce judgment will usually be granted one year after your date of separation.

**Documents That We require:**

- ◆ A copy of your original marriage certificate issued by the province or the original registration of your marriage.
- ◆ A copy of all (if any) Court Orders, Separation Agreements, and any other written arrangements which pertain to the marriage or any children of the marriage. If you have only an oral agreement, please describe the terms and provide the date of the agreement.

**Our Guarantee:**

- ◆ We guarantee that your divorce forms will be properly completed in accordance with the information that you provide and the Divorce Act (Canada), and if a divorce is not granted, we will correct the problem or refund your money.
